1) At its meeting on 17.6.2019, the Misgav Regional Council approved the following in full:

- (A) The 2020 Municipal Tax Order for the Regional Council, which is updated to a rate of 2.58% compared with 2019, as per the automatic update required for 2020.
(b) The request for special authorization to Ministers (Interior and Finance) for a reduction at a rate of 33.3% on the tariff "Agricultural buildings excluding greenhouses" (in Rates Order subclause 11.1, codes 17+47+81) and to the tariff "Greenhouses, rigid or temporary construction" in: Municipal Tax Order: subclause 11.2, codes 18+48+82)

2. On 19/12/19 the Regional Council's request for a special reduction for 2020 at a rate of 33% on all properties designated in the Tax Order in Series 11 was approved.
The request for special authorization for 2020 filed by the Regional Council and the Ministers' approval are published on the Regional Council's website.

How to pay your municipal tax:

- (a) If you have a fixed payment schedule- the existing payment schedule will continue, and the appropriate amount of municipal tax will be collected each month
If you wish to pay the entire annual amount in advance, please pay using the voucher attached to this assessment, which is for 11 months (February - December 2020), by the date specified, 15.2.2020.
The sum due for January will be collected on 10.2.2020, via the payments schedule.

- (b) If you pay your annual municipal tax in advance, by 15.2.2020, or if you pay via a fixed monthly order direct to the Council, or via centralized collection via the settlement, you are entitled to a 2% discount on your rates.

Each month, the Council sends out a municipal tax voucher for payment by the 10th of the upcoming month.
Please check the billing information (description of charges and property size).
Details and deadlines for filing objections to your municipal tax are provided on the back of the voucher.
