- Discussing Schusterman Publicly: It can be used to inform how we talk about Schusterman, our mission and our work with outside audiences, including peers, colleagues and grantees.
- **Developing Materials:** It can be used to form the basis of materials, either at the organizational level or for specific portfolios, programs or initiatives.
- Helping Grantees and Partners Talk About Schusterman: It gives grantees and other partners easy to use boilerplate to include in their materials or to explain who Schusterman is to their audiences.

#### **Our History and Evolution**

- Charles and Lynn Schusterman began their family foundation in Tulsa, OK, in 1987, focused on strengthening the Jewish people, Israel and their hometown of Tulsa. They co-led the foundation until Charles passed away in 2000. Lynn led and expanded the foundation geographically and programmatically for the next 15 years.
- Their daughter, Stacy, joined her as Co-Chair of the Foundation and became
  Chair in 2018. She has built upon the family's legacy philanthropy in the Jewish
  community, Israel and Tulsa, as well as expanded it to include racial, gender and
  economic equity in the U.S. through investments in K12 education, criminal
  justice, gender and reproductive equity, and voting rights.
- The family's Jewish values have always been at the core of their philanthropy: a commitment to the pursuit of justice (tzedek), repairing the world (tikkun olam) and treating all people with dignity and respect (derekh eretz).

## **GUIDING PRINCIPLES**

This section goes a layer deeper than the key points above to provide context for Schusterman's work and worldview.

These principles lay out why we support the work that we do.

We are an organization rooted in Jewish values. This means that Jewish values guide and animate our work, and we are committed to pursuing justice (tzedek), repairing the world (tikkun olam), and treating all people with dignity and respect (derech eretz). Our commitment to Jewish values also means a commitment to strengthening the future of the Jewish people and Israel. Core to this work is engaging young people through joyful, meaningful and inclusive Jewish experiences and by cultivating a new generation of diverse and dynamic Jewish leaders.

We are committed to helping both the U.S. and Israel live up to their highest ideals. We recognize that both countries are on a journey of continuous improvement, and we are committed to supporting that growth through our grantmaking and advocacy activities. Our work focuses on helping both countries create more just and inclusive societies.

We are committed to advancing equity. In the U.S., we focus on addressing systemic racial, gender and economic barriers that prevent people and communities from realizing their full potential. Our investments across our Criminal Justice, Education, Gender and Reproductive Equity, and Voting Rights portfolios focus on the many ways individuals and communities experience systemic oppression and discrimination. We have also made significant investments in pursuing LGBTQ equality and belonging in Jewish life and Israel, as well as to advance racial and gender equity within the U.S. Jewish community. In Israel, our DEI work is focused on deepening our understanding of the rich diversity of Israeli society, placing it in its unique historical context, and examining the opportunities and complexities it creates.

We believe in Zionism. We believe in the Jewish people's right to self-determination and a safe, secure state, especially after a long history of persecution, expulsion and threats of annihilation. Our vision of Zionism centers on supporting Israel as a secure Jewish and democratic state rooted in its founding principles of equality and inclusion for all its diverse citizens, including Jews, Arabs, LGBTQ+, secular, religious, Mizrahi, Ethiopian, Ashkenazi and more. We work with many different communities in Israel, recognizing that their well being is inextricably linked. We support efforts to encourage dialogue across sectors, preserve democracy and ensure equal rights for all, and build pathways for people to live together in a shared society. While a negotiated two-state solution may be difficult to achieve in the near term, we support efforts to ensure it remains a viable option so that Israelis and Palestinians can each have a state and live in peace alongside each other and provide better lives for their families.

These principles, developed within the frame of our core values (equity, impact, optimism, collaboration, and humility), lay out how we express these values in the work we do.

We seek to embed equity in how we approach our work. Equity is both an outcome we seek to advance and also how we strive to approach our work. We want to create an organization and partnerships which embody the diversity of the communities we work with – and we know that having a range of backgrounds and perspectives makes our work stronger and more effective. We are committed to deep learning and continuous improvement in this area, and to reflecting on and adjusting our processes, policies and language to ensure they are as inclusive and equitable as possible.

We seek to maximize impact throughout our work. Complex problems require long-term solutions. We work on systems-level change and believe that effecting that kind of change requires embracing innovation and risk-taking throughout our work. We recognize that no one strategy or tactic will yield the results we are working toward, so we employ multiple pathways, including grantmaking, operating programs and advocacy activities, in pursuit of our goals.

We put a premium on collaboration and partnership across our work. While we are willing to be a leading voice and funder on our priority issues, we prioritize working in close collaboration and partnership with our peer funders, allies and grantees. We also prioritize making connections between leaders and organizations working on similar issues. We approach all our work with humility meaning that we do not think we have all the answers, that we view our partners as the experts and that we are deeply committed to ongoing learning.

We embrace complexity and possibility. We understand that, for many of the issues we work on, there are no quick and easy answers, but we do believe there are meaningful solutions. We believe it is important to create space to grapple with difficult questions, foster dialogue across differences, and ensure that those conversations are always rooted in mutual respect.

We seek to amplify the experience and voices of the communities with which we partner. Instead of prioritizing our own voices or public profile, we strive to uplift the work of our grantees and the perspectives and experiences of those most proximate to the issues on which we work.

## **VOICE AND PERSONALITY**

This section is for internal use and is intended to guide content and communications. Our voice is grounded in our values and cultural principles. If people were to describe us, we hope they would say we are:

- **Humble.** We don't seek the spotlight, but we are willing to speak out when it matters. When we speak, it comes from a place of purpose, not ego. We use our power as funders to amplify the voices, stories and contributions of others. We don't assume we know everything about the people impacted by our work and strive not to speak for them. We acknowledge when we get it wrong and are always willing to reflect, learn and improve.
- **Driven.** Our drive is fueled by a mix of optimism and realism. We are passionate, positive and solutions-focused even—and especially—in tough situations. We are motivated by our values and focus on building and sharing knowledge that can lead to new ways of achieving better results. We are not afraid to try a new approach to solve a problem or fill a gap.
- **Approachable.** We say what we mean and mean what we say. We use clear, direct language and avoid both jargon and slang. If our language were an attire, it would be "Business Casual." We also strive to be accessible to our grantees as our partners in this work.
- **Caring.** We work on systemic change, and we are in this work because we care about people. We use inclusive language and aim to amplify the experiences and voices of people of diverse backgrounds, faiths, perspectives and orientations. We focus on communities' aspirations and assets, rather than their challenges.
- Nuanced. The issues we work on are complex, and we are willing to take complex
  positions, even ones with which some of our staff and closest partners may
  disagree. We are driven by our values and believe robust debate is a healthy part of
  a strong democratic societies and Judaism.
- **Empowering.** Our belief that change is possible is what motivates us. The challenges are great—but so too is the potential for people to work together to meet them. We want to make a difference and build a world that future generations can be proud to inherit. We amplify stories of collaboration and innovation and share learning and insights to help others create positive change.

Through our communications, we strive to influence others with our ideas. While we are not seeking a prominent public profile, we do want the Schusterman name to be connected to our work related to advancing racial, gender and economic justice, and to strengthening the Jewish community and Israel. We leverage our public profile and presence when it is in service of our overall goals and when we believe it is critical to advancing our work and our values.

#### We do this by:

- Reflecting our values of equity, impact, optimism, humility and collaboration.

  This means we reference and use them as key themes as often as possible in our writing and through our storytelling.
- Emphasizing dignity and respect for the people and communities impacted by our work.

This means we use people-first language and the terminology that different identity groups use to self-identity/speak about themselves when referring to them.

Using our voice to stand for our values and grantees.

This means we believe in both leadership and allyship. While it is our preference to amplify the voices and stories of our grantees, we are willing to speak out publicly when we believe it is critical to advancing our work.

Leading with our grantees, not our dollars.

This means we prioritize the voices of our grantees and the people who work hard every day to make a difference on the issues we support.

It also means we and our investments are not the headline but may be referenced in a supporting capacity.

- Announcing investments when we believe it will advance our overall goals.

  Our philosophy on how we talk about how much money we give in general, to specific portfolios and to specific grantees is still evolving. Right now, we make the determination on a case-by-case basis.
- Having a public-facing narrative that is consistent and has integrity but is not comprehensive.

This means that we do not think it is necessary to list every single grant on our public-facing website; rather we are committed to listing a representative sample to illustrate the scope of our work.

Speaking to a diverse audience.

This means we see our audiences as diverse in perspectives and backgrounds and in the identities they hold. We are conscious of the role language can play in perpetuating power dynamics, and we seek to avoid, and to challenge when possible, language that leads to perpetuating inequities.
