Senior Editor: The authors have clearly articulated the concerns of reviewer 2 and most of the concerns from the

associate editor. However one major concern exist.

From the last review: There is still no clear reference to the actual qualitative method used in the study starting in the abstract. Vague reference to "qualitative study" does not relay the potential rigor of the study. The authors indicate that the data was from a previous qualitative study but still no mention of the actual method.

Your response to this concern in revision 2 was: The method used for the qualitative study is interviews. We conducted a total of 34 interviews with disaffiliates, over the course of two years. These were semi-structured interviews. We have edited the Methods section to include more information about the actual method used.

I was asking the authors to clearly articulate the qualitative method used to guide the study. This could be something like phenomenology, focused ethnography, discourse analysis or a variety of other qualitative methods. Interviews are not a qualitative method but rather the process of collecting data, same with semi-strucuted interview guide. Again what you have listed is not a clear articulation of the actual qualitative method used for your study. You make reference to in the content analysis section about interpretative phenomenology and Atlas software as methods. The content analysis was the data analysis and Atlas software is a tool that assist with data management and is not a method for analyzing the data. As a reader I am confused with and how interpretive phenomenology was used to analyze the data when you discuss content analysis.

Please offer a clear statement and description of the qualitative method used to guide the study. Also clarify the concerns in the data analysis section.

Regarding the research question. Even though what you are reporting is a continuation of a previous study there should be some articulation of a research question beyond the purpose of the study even if extending a previous study. There is a disconnect from a research perspective about the research questions and therefore the intentions of your study. Stating the purpose is not enough and articulating the RQ promotes methodological congruence and rigor.

You can not just say "interviews" as all qualitative research is interviews. Is it focus groups, is ti private interviews? Using SQRS will not only increase the scientific integrity of the paper but will also increase the ability for it to be used as an evidence-based paper. If you cannot make the changes we have requested, we will not be able to accept the paper. Dr. Cuellar
