Pursuant to SCPA 1750-b, the guardians are authorized and empowered to make all health care decisions with respect to the medical and dental needs of the ward and to render consent to any medical procedures which are necessary to the health and welfare of the ward unless the court directs otherwise; In the event that a decision is made under SCPA 1750-b to withhold or withdraw life-sustaining treatment for the ward, the guardian shall cause the attending physician to immediately notify, at least 48 hours prior to the implementation of such decision, this court and Mental Hygiene Legal Service, and any objection by any such party, orally or in writing, shall immediately suspend such authority until a hearing is conducted by this court.

Property of the Ward is subject to joint control with the Chief Clerk of Rockland County Surrogate Court; no withdrawals, transfers or investments are legal without Court Order; the Guardian may not receive any funds or property of the Ward except jointly with the Chief Clerk of Rockland County Surrogate Court.


Hon. Thomas E. Walsh II, Acting Surrogate:

This application is made pursuant to Article 17-A SCPA for the appointment of guardians of the person and property of an alleged developmentally disabled person and for the authorization to make all decisions with respect to the medical and dental needs of said developmentally disabled person and to render consent to any medical procedures which are necessary to the health and welfare of said developmentally disabled person.

Upon the oral proof adduced at the hearing held on Tuesday, February 15, 2011, and the documentary proof submitted in support of the application by Mental Hygiene Legal Service, and presence of the respondent having been dispensed with at the hearing, it appears to the court's satisfaction that the respondent is a developmentally disabled person within the provisions of Article 17-A SCPA. The application is granted and letters of guardianship of the person and property of the respondent will issue to the petitioners upon duly qualifying according to law. The decree to be made herein shall provide for the designation of the Clerk of this Court to collect and receive any funds of said developmentally disabled person jointly with the guardians hereinabove appointed.

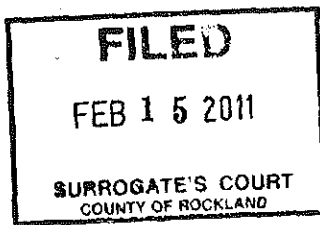

Pursuant to SCPA Article 17A
Developmentally Disabled.

A verified petition having been filed by Esther Gable and Ralph Gable praying for a decree appointing guardians of the person and property of the developmentally disabled person, and the Court having been satisfied that sufficient medical certifications have been provided and that such condition is permanent in nature or likely to continue indefinitely, and it appearing that jurisdiction having been obtained over all necessary parties, and the Court being satisfied that the interests of the respondent will be promoted by the appointment of guardians and that the proposed guardians are in all respects competent to act, it is hereby

ORDERED AND DECREED, that Esther Gable and Ralph Gable be and are hereby appointed guardians of the person and property of Abraham Sender Gable, a developmentally disabled person, and it is further

ORDERED AND DECREED, that Chana Selmon is appointed Standby Guardian for the developmentally disabled person subject to the confirmation by the Court pursuant to SCPA 1757; and it is further

ORDERED AND DECREED, that Rena Bussu is appointed First Alternate Standby Guardian for the developmentally disabled person subject to the confirmation by the Court pursuant to SCPA 1757; and it is further

ORDERED AND DECREED, that Achiezer Gable is appointed Second Alternate Standby Guardian for the developmentally disabled person subject to the confirmation by the Court pursuant to SCPA 1757; and it is further

ORDERED AND DECREED, that pursuant to SCPA §1750-b, the guardians are authorized and empowered to make all health care decisions on behalf of the developmentally disabled person to render consent to any medical procedures which are necessary to the health and welfare of the developmentally disabled person; and it is further

ORDERED AND DECREED, that in the event that a decision is made by the guardians under SCPA §1750-b to withhold or withdraw life-sustaining treatment for the developmentally disabled person, the attending physician as defined in SCPA §1750-b shall immediately comply with the provisions enumerated in SCPA §1750-b, and it is further

ORDERED AND DECREED, that the filing of a bond be dispensed with, and that the guardians collect and receive all money and property of the developmentally disabled person pursuant to SCPA §1708 jointly with the Chief Clerk of the Surrogate's Court of Rockland County, and that all such money and property be deposited or invested in the name of the guardian subject to the further order of the court with the depository hereby designated, M & T Bank, 66 Route 59, Monsey, New York provided, however, that no deposit or investment in any one depository shall exceed the maximum insured amount and such deposit or investment shall be withdrawn or removed only on the order of the Court; and pursuant to SCPA §1719 the guardians shall file with the Court all annual accounts as required by law; and it is further

ORDERED AND DECREED, that said guardians are restrained from collecting and receiving any money or property except under joint control as aforesaid, and the letters to be issued shall be limited to the receiving and administration of the money or property under such joint control, and it is further

ORDERED AND DECREED, that Letters of Guardianship of the person and property be issued to Esther Gable and Ralph Gable upon properly qualifying for such office

ORDERED AND DECREED, that the authority of such guardians be restricted in accordance with, and that the letters herein issued contain, the limitation(s) as follows:


