To Whom It May Concern:

This office represents Ralph and Esher Gable with regard to the Guardianship of Abraham. The Gable's have requested that this office responds to your email fo 6/5/2019. A copy of the email and Gable's authorization to communicate with our office is attached.

The February 15, 2011, Surrogate's Court Decree appointed Abraham's parents as Guardians of both his Person and Property. The authority of the Guardian of the Person of an individual with a disability, in essence re-establishes all their rights as Parents as if the individual was still a minor. That includes the authority to take him to another state or country and establishing a new residence.

The reason that there is special mention concerning health care decisions is two fold. First, this was a special section of the law that was enacted many years after the original law came into existence, and not all individuals who have Guardians are unable to make their own health care decisions. Second, it empowers the Guardians to make end-of-life decisions for Abraham, which is an extraordinary authority under any circumstance.

We reached out to the Court to see if the Court would entertain a request to have a specific authority identified by Court Decree to move Abraham to Israel. The Court said it would not act since "the Guardians already have that authority."

This office has represented many Guardians who have moved their family, including their adult child with a disability, to Israel and for that matter to Ireland and other countries.

The Parents, as Abraham's Guardians, have full authority to move him to Israel permanently. It is then up Israel if a further Guardianship proceeding needs to be instituted.

I hope this clarifies the situation and allows the family to join their other children in Israel.
