#### Summary of my research work: past, present and a look to the future

The conditions that enable the existence of substantive democracy are the Ariadne's thread that runs through my research work in the field of public law (constitutional law, administrative law and criminal law). It is this very same thread which connects my academic work to my public work as well.

My research has examined "first generation" rights and "second generation" rights, as well as areas of public law that have a significant impact on a democratic society. The main part of my work relates to the development of a dialogue regarding subjects that are not sufficiently discussed within Israeli law.

With respect to rights, my work has been focused on the right of access to the courts; the right to education; as well as social, economic and cultural rights and the right to equality — with an emphasis on the application of these rights with respect to disadvantaged groups within the society. Another area in which I have integrated both my research and practical work and public engagement is freedom of information. My research concerning criminal law has also emphasized the treatment of minority groups and special population groups within the criminal process. My research in the area of state audit is also closely tied to the study of the conditions that make it possible for a proper democratic regime to exist. The following is a summary of my various areas of research.

The right to access to the courts – My first steps in the world of research began with the publication of my LL.M. dissertation as a book, Access to Court as a Constitutional Right (Bursi Law Books Publishing, 279 pages, 1998). The right of access to courts, as a human right, is closely tied to the basic principles of democracy and bears on social aspects as well. This research was, at the time, a pioneering work (see the remarks of Justice Hanan Melzer in Civil Rehearing 5698/11 State of Israel v. Dirani, regarding the right of access to courts in Israel: "Professor Yoram Rabin enjoys the credit for having first written on this matter"). In this book, I laid out the substantive foundations for a constitutional determination of the right of access to courts under Israeli law, and on their basis, I examined the various legislative arrangements that impact on the right of access to the courts (see also: Yoram Rabin, The Right of Access to Courts - From an Ordinary Right to a Constitutional Right, 5 HaMishpat 217, 2000).

Over the years, I have published several papers dealing with specific aspects of this right of access to courts (see: Yoram Rabin, *The Right to Counsel and Legal Aid in Civil Proceeding*, 6 **HaMishpat** 225 (2001); Liav Orgad & Yoram Rabin, *Access to Courts for Enemy Aliens*, 29(2) **Bar-Ilan Law Studies** 469 (2014); Yoram Rabin & Alon Rodas, *Restraint Orders*, 5 **Attorney's Office Law Journal** 137 (Aug. 2019); Yoram Rabin & Alon Rodas, *Testamentary Clauses that Restrict Access to Courts*, **Yoram Danziger Book** 595 (2019)). My research in this field had a significant impact on the formulation of Israeli law on the subject. Indeed, the book and the articles have been cited dozens of times in judgments of the Israeli Supreme Court, the Israeli District Courts and in legal literature. Some twenty years that have passed since the book's publication, and I am currently working on updating it, with the objective of publishing a second edition that will include the many developments that have since taken place in the field.

The right to education – My book on the right to education constitutes – to the best of my knowledge – the most comprehensive work written in Israel todate on this

subject (Yoram Rabin, The Right to Education (Nevo Publishing, 578 pages, 2002)). At the time the book was published, there were no studies dealing with the normative status of the right. The main, and at the time innovative legal proposition presented in this book was that the right to education should be viewed as a constitutional right because widespread education is a necessary condition for both the establishment and the maintenance of a cultivated society. In that book, I proposed that it is not sufficient to examine [the right to] education at a legal level, through the narrow perspective of the country's education laws, and that it must also be anchored as a constitutional human right in the country's constitution (For a summary of the substantive model developed in my book, see also Yoram Rabin, The Many Faces of the Right to Education, Exploring Social Rights - Between Theory and Practice 265 (Hart Publishing, Oxford, 2007)). The theory developed in my work was further advanced and refined in a number of contemporary studies, regarding global and local developments; substantive issues such as special education, home schooling; and, procedural issues such as subject matter jurisdiction (Yoram Rabin & Keren Meidar, On the Right to Education and the Right to Equal Education in the Field of Special Education, 8 HaMishpat 541 (2003); Yoram Rabin & Keren Meidar, On the Right to Education and the Right to Equal Education in the Field of Special Education, 8 HaMishpat 541 (2003); Yoram Rabin & Tamir Shaanan, Jurisdiction Ratione Materiae over Education-Related Petitions 49(1) HaPraklit - The Israeli Bar Law Review 257 (2006)). In 2017, I was invited to write the "Right to Education" entry in the Max Planck Encyclopedia of Comparative Constitutional Law (Yoram Rabin & Matan A. Gutman, The Right to Education, Max Planck Encyclopedia of Comparative Constitutional Law (Rainer Grote, Frauke Lachenmann, Rüdiger Wolfrum eds., Oxford University Press, 2017).

Social rights – I took upon myself (together with Yuval Shany) the editing of the book *Economic, Social and Cultural Rights in Israel* (Ramot Publishing - Tel-Aviv University, 2004). Until the publication of the book, these rights had not been the subject of any orderly and in-depth discussion in Israel. As then Chief Justice of the Israeli Supreme Court, Professor Aharon Barak, wrote in his introduction to the book, social rights are "an idea whose time has come." (Yoram Rabin & Yuval Shany, *The Social Rights: An Idea Whose Time Has Come*, Economics, Social & Cultural Rights in Israel 11 (Yoram Rabin & Yuval Shany, eds., Ramot Publishing - Tel-Aviv University, 2004)). The book includes articles by judges and scholars and comprises a general and comparative view; a discussion of particular rights (Yoram Rabin, *Social Rights from the Procedural Sphere*, Economics, Social & Cultural Rights in Israel 765 (Yoram Rabin & Yuval Shany, eds., Ramot Publishing – Tel-Aviv University, 2004)), and a study of the challenges that arise in the application of the rights to special population groups. The book laid out the basis for a discussion of social rights in Israel and is considered a foundational book in the field, up through the current time.

Freedom of information – In due course, I came to the understanding that processes of legal-social change cannot be limited to academic research and writing. Impact requires both knowledge and action. Thus, in 2004, I worked together with journalist Raviv Druker and Dr. Yuval Karniel to establish the Movement for Freedom of Information in Israel. Freedom of information is a key tool for social change; for increasing citizens' engagement; and for enhancing the accountability of public servants and elected officials. The latter hold information that belongs to the public, in trust, and they are also responsible for protecting the values of democracy. The Freedom of

Information Law was enacted in Israel in 1998, but its use to promote values, as described above, was originally insignificant. The establishment of the Movement for Freedom of Information, and the activity of that organization, brought the matter of the right to obtain information from public entities to the attention of the general public. The law is now used by citizens, journalists and various non-profit organizations, on a regular basis. Along with my public work and the initiation of several lawsuits regarding freedom of information, I wrote a number of papers that established the theoretical justifications for the exercise of the right to information and the constitutional aspects of that right (Yoram Rabin & Roy Peled, Between FOI Law and FOI Culture: The Israeli Experience 1 (Issue 2) Open Government: Journal on Freedom of Information (2005) 41; Yoram Rabin & Roy Peled, Seven Years of Freedom of Information: Has the Desired Transparency Been Attained? 11 HaMishpat 625 (2007); Roy Peled & Yoram Rabin, The Constitutional Right to Information, 42 Columbia Human Rights Law Review 357 (2011); Yoram Rabin & Roy Peled, The Constitutional Freedom of Information, Dalia Dorner Book (Nevo Publishing, 2009)). These studies have been cited in numerous court decisions.

**Criminal law** – In recent years, my main area of research (and teaching) is criminal law. In that field too, my point of departure is the significant impact constitutional law has on substantive criminal law, and the ways in which human rights affect the design of criminal legal norms. For several years, I have been working on a very comprehensive research project – the writing (together with Yaniv Vaki) of a criminal law text-book. In 2008, the first edition of my book *Criminal Law* was published. The third edition was published in 2014. This book is the most up-to-date treatise on this subject in Israel, and it has been cited in hundreds of decisions of the Supreme Court and of other judicial panels.

Additionally, the promotion and protection of minority members' rights and the rights of members of disadvantaged groups has a special importance in the context of criminal procedure. Along with the book, I published a number of specific studies regarding criminal law, in which I examined the treatment, under Israeli criminal law, of defendants who are members of specific population groups, as well as the protection afforded by the law to certain types of victims of crimes. Thus, for example, I examined the manner in which the criminal process relates to defendants who suffer from PTSD; to defendants who have committed property-related crimes out of an existential need; and to criminal responsibility for harming the life of a fetus (Yoram Rabin, Yonatan Livni, Post-Traumatic Stress Disorder as a Defense in Criminal Law, 5 Haifa Law Review 205 (2010); Yaniv Vaki & Yoram Rabin, Stealing out of Necessity, 85 HaMishpat' Online: Human Rights 4 (Dec. 2018); Yoram Rabin & Yaniv Vaki, The Criminal Responsibility for Killing a Fetus, 3 Attorney's Office Law Journal 150 (Dec. 2015); Yoram Rabin, Yaniv Vaki & Isaac Becker, From Ancient Israel to Modern Israel: The Historical Development of the Protection of a Fetus in Criminal Law, 50 Israel Yearbook on Human Rights (forthcoming 2020)). I further focused on differences in penalties given to Jewish and Arab defendants in Israeli courts - relating to the right to equality in criminal proceedings (see: Giora Rahav, Yoram Rabin & Eppi Yuchtman-Yaar, Disparities between Jews and Arabs in the Israeli Criminal Justice System 13 Ohio State Journal of Criminal Law 233 (2015); Giora Rahav, Eppi Yuchtman-Yaar & Yoram Rabin, Disparities between Jews and Arabs in the Israeli Criminal Justice System 54 Hapraklit – The Israeli Bar Law Review 3 (2016); Yoram Rabin & Yaniv Vaki, The Racial motive in Criminal Law, 103 The Bar 40 (Feb, 2015)). In the near future, I plan to complete the writing of the fourth edition of *Criminal Law* and to publish a new book on killing offenses.

State audit – As noted above, alongside my research and teaching, I wanted my work to lead to social change and to contribute to the strengthening of the Israeli democracy. For most of my career, I worked to achieve this goal within the walls of academia and through my public activism in the Movement for Freedom of Information and in the Israeli Society for Public Law. In 2016, I was chosen to serve as the Legal Advisor to the State Comptroller and Public Ombudsman. State audit has tremendous influence on the forte of a democracy. It promotes the accountability of public servants and elected officials, and it works to improve the operations of government authorities and to ensure proper administration. It constitutes an important element of the protection of human and civil rights. Within the framework of this position, which I held for three years, I combined theory and practice. At the time that I became the Legal Advisor, the substantive and research field of state audit, which had held a certain importance during the 1980's and early 1990's, was in a static condition. When I assumed my role at the State Comptroller's office, I took upon myself the editing of the "Israel Journal of State Audit", and put it through a process of academization. I did this with the objective of reawakening an in-depth discussion within the field of state audit. During this period, I studied various aspects of state audit myself – aspects which were relevant both from an Israeli perspective and from an international perspective. These issues included real-time audit, and the process to be applied when State audit raises the suspicion of criminal conduct (see: Yoram Rabin & Inbal Efron-Weinstein, Real Time State Audit, ICON-SIL Blog (27 Nov. 2019); Yoram Rabin & Tehila Winograd, State Audit Work that Raises a Suspicion of Criminal Conduct – the Case of Israel, 63 Israel Journal of State Audit (2019)). I also lectured on the subject of state audit in a variety of forums.

To sum up, I have written 3 books (one of which, written after my last promotion, comprises three volumes, and was published in three edition) and 44 articles, chapters in books, and encyclopedia entries (of these, 23 were written since I received my current academic rank). Said publications, some of which enjoy high ranking, have had an impact not merely in the world of scholarship but also in the world of legal education and legal practice, as is evidenced by quantitative measurements of citations by the Supreme Court and other judicial institutions. In addition to these, I wrote 12 case notes - all after I received my current academic rank. As noted above, all of my writings focus on public law (including criminal law), and the common denominator for all is a query into the conditions that enable the existence of a substantive democracy. This indeed is my fingerprint in legal research, one recognized both in Israel and elsewhere. Since said existence is ever more fragile, I plan to continue devoting my research to this issue. Finally, in my current position as the head of an institution of higher education, I am fully committed to encouraging our faculty members to be extensively engaged in research. I translate this commitment into practical ways and means to facilitate their engagement.
