2. PROFESSIONAL EXPERIENCE

As from January 1996 started working exclusively as freelance translator from English, German, Spanish and French into Portuguese.

Since September 1999 joined the Freelancer Translation Team of the European Central Bank as external consultant, working nowadays with this institution on a freelancer basis and in-house, replacing the Portuguese translators. In August 2004 signed the 1st framework contract with the ECB, renewed every 4 years until now.
