From Schlemiel to Sabra: Zionist Masculinity and Palestinian Hebrew Literature (Indiana University Press, Forthcoming) This study reexamines early twentieth century Hebrew prose and drama to reveal how a coterie of Palestinian Hebrew writers deployed gender and sexuality to advance a Zionist masculine form grounded in reflection and investigation of one's own actions. This constituted one of many variant masculine models inspired by previous Jewish and by contemporary non-Jewish models which were being promoted in the Palestinian Jewish public sphere for diverse Zionist agendas' advancement. Its emphasis on providing Palestinian Jewish men with a sense of continuity with their Diasporic past distinguished it. Through presentation of the ways in which these Palestinian Hebrew literary texts promoted "self-evaluative masculinity" and indeed the ways in which their authors struggled against those promoting divergent masculine forms for acolytes, this study challenges earlier claims that Palestinian Jewish/ Israeli masculinity emerged through utter rejection of Diasporic Jewish masculinity and facile imitation of pre-existent Christian European norms.

Yiddish Literature and Culture in America

Developed course that employs American Yiddish culture to transmit knowledge of the immigration process and the challenges faced by ethnically and racially divergent immigrants as they work to find their desired place in an increasingly multicultural environment through analysis of Yiddish letters, biographies, prose, poetry, and film. Short response papers and lengthier writing assignments are employed to develop student writing skills.

Yiddish Literature and Culture in Europe

Developed course introducing students to European Yiddish culture with special attention given to prose, poetry,

and film produced between 1864 and 1945. Through short writing assignments students develop their analytical writing skills.

#### Israeli Fiction in Translation

Designed course employing eight leading Israeli authors' literary works to introduce students to Israeli society's contemporary character. Surveyed topics include Zionism and post-Zionism; Globalization; Israel as a Jewish and democratic state; the Israeli military's influence on civilian life; terrorism and its effects on national life.

An Eye to Zion: Jerusalem in Israeli History and Culture (Reading in Contemporary Hebrew Literature II) Since its conquest by David approximately 3000 years ago, Jerusalem has played a central but shifting role in Jewish life. Different Jews and different times have assigned it divergent meanings. While some have stressed its tangible aspects, Jerusalem's mythic, symbolic, and political dimensions dominate how most people perceive it. This newly designed course opens with an historic overview of Jerusalem's Hebrew cultural representation before shifting its attention to Zionist and contemporary Israeli representation of the city in literature, film, and television.

Palestinian Israelis: Reality and Representation (Readings in Contemporary Hebrew Literature I) While most people view Palestinians as dwelling in the West Bank, Gaza, and in Diaspora, many Palestinians live in the State of Israel, where they compose 25% of the total population. This newly fashioned course investigates these Palestinians and their representation in Israeli and Hebrew literature, film, and television. Representations of Palestinians created by Jewish artists, as well as Christian, Muslim and Druze Palestinians, are explored. Through concentration on this theme, the course simultaneously introduces students to Israeli social and artistic issues and assists them in development of Hebrew language skills.

Secularity and Religiosity in Modern Hebrew Culture (Readings in Contemporary Hebrew Literature II) Designed course employing analysis of Hebrew poetry, prose and film, and discussion of secondary readings to examine the popularly held belief that one of Israeli society's primary cleavages has been created by the differences between secular and religious Israeli Jews. Through introduction of the term civil religion, the course questions whether Jewish religion might unify Israeli Jews. Linked course goals include enhanced student familiarity with and appreciation of Israeli art and their development of Hebrew language skills.

# The Military and Israeli Identity (Reading in Contemporary Hebrew Literature I)

Created course employing Israeli poetry, short stories, film, and oral testimony portraying military experience, as well as secondary literature analyzing military life and its place in Israeli life, to chart changes in Israeli society since the establishment of the State of Israel in 1948. Simultaneously the course introduces students to important works of Israeli art and assists them in developing their Hebrew language skills.

# Mizrahi Representations (Readings in Contemporary Hebrew Literature II)

Fashioned course that employs analysis of poetry, short stories, and films portraying non-Ashkenazic Jews, and discussion of secondary sources dealing with the invented ethnic category "Mizrahi," to provide students with greater aesthetic appreciation of Hebrew culture and an introduction to the cultures of non-Ashkenazic Jews, as well as one of Israel's primary Jewish ethnic cleavages and how this cleavage manifests itself socially, economically, and politically.

## Tel Aviv Stories (Readings in Contemporary Hebrew Literature I)

Developed course teaching students about the synchronic and diachronic variation in Tel Aviv's representation and how this variation can be employed to trace Israeli society's development. The course pursues these objectives through discussion of secondary sources dealing with Tel Aviv's history and symbolic character and analysis of memoirs, poetry, short stories, and films focusing on the city.

# Contemporary Israeli Culture (Readings in Contemporary Hebrew Literature II)

Designed course exploring the new Israeli culture that has emerged over the last thirty years due to the gradual dissipation of the sense of collective identity, shared interests, and mission that animated Israeli society in the early state period. Through analysis of recent Hebrew short stories, poems, films, and music, this course examines this new culture's contours, as well as artistic developments in Israel's Modern Orthodox and Oriental Jewish sub-cultures.

Hebrew Literary Representations of the Holocaust (Readings in Contemporary Hebrew Literature I)

Created course investigating Holocaust representation in prose, poetry, and life writing. Through readings in variant texts written by the Holocaust's victims, contemporary Jewish bystanders, survivors, second generation writers, and contemporary authors, the course teaches students how time and location of composition, as well as authorial biography, lead to divergent representations with variant messages concerning the Holocaust.

#### Introduction to Hebrew Literature

Developed course intended for third-year Hebrew language students that provides them with an overview of twentieth century Hebrew literature and reinforces Hebrew language skills previously acquired through extensive writing. Through readings in 11 works by leading Hebrew writers, students gain knowledge of important shifts in Hebrew culture including changing attitudes to the Diaspora and the Land of Israel.

## Modern Jewish Literature

Designed literature course employing fiction written in Hebrew, Yiddish, German, Russian, and English, to introduce students to the work of twelve prominent Jewish writers while simultaneously providing them with a general overview of major trends within Modern Jewish Literature capable of enhancing their understanding of these and other works by modern Jewish authors.

# Assistant Professor of Hebrew Literature, Tulane University Director of Hebrew Language Program

Modern Hebrew Literature and the Bible

Developed a course investigating the ongoing dialogue between the Jewish people and their defining text. By reading the Hebrew Bible alongside subsequent Rabbinic and twentieth century Hebrew texts, this course exposes students to the way Jews interpreted the Biblical text to make it relevant to their time and place. Such reading works to teach students about Israeli culture and the ways in which it breaks with and carries forward elements of the Jewish religious past.

#### Selected Themes in Israeli Film

Created course introducing students to Israeli cinema and society through the viewing, analysis, and discussion of 13 films. The religious-secular divide, the Israeli-Palestinian conflict, military-civilian relations, and marginal groups in Israeli society serve as topics around which the viewing and discussion of films are organized. Through comparison of films treating similar themes students learn about the dynamics animating Israeli society.

# Introduction to Jewish American Literature

Developed course employing Yiddish and English works of 14 different Jewish writers composed in the United States over the course of the last 100 years to investigate the different ways these writers interpreted the amalgamation of *Jewishness* and *Americanness* suggested by the designation "Jewish American Literature."

## Representing the Holocaust/Holocaust in Literature and Film

Created course employing diaries, literature, film, and the graphic novel for the study of Holocaust representation. Divided into four units - wartime diaries and ghetto writing, the work of adult survivors, texts by child survivors, and second-generation writing- this course uses diverse material drawn from numerous national and linguistic traditions to explore the different ways that the Holocaust has come to be represented.

# Israeli-Palestinian Conflict in Literature and Film

Created course introducing students to the works of fifteen leading Palestinian and Israeli writers and directors. Through analysis of these works, the course explores the aesthetic, moral, and political dimensions of the Palestinian-Israeli conflict. Rather than viewing these works as mere reflections of external events or as purely aesthetic creations, this course investigates how these representations shape the attitudes of their readers and viewers.

## Introduction to Israeli Literature

Created honors class employing the works of fifteen key Israeli writers to introduce students to Israeli literature. Through close readings of short stories, this class works to develop student textual skills. Prominent themes addressed in this course include the changing role of family in Israeli society, the emergence of urban literature, the expanding role of the Holocaust in Israeli fiction, the literary representation of Arabs in Israeli literature, and changing gender roles in Israeli society.

Israeli Film

Designed survey class employing fourteen key Israeli films to introduce students to Israeli society and its cinematic tradition. Popular cinematic themes treated include divergent approaches to Israel's origins, the Holocaust's impact on Israeli society, the place of Palestinians within Israeli society, Mizrahim in Israel, the rise of Israeli individualism, and the changing role of immigrants in Israeli society.

#### Introduction to Jewish Civilization

Designed survey class covering the biblical, ancient, medieval, and modern periods of Jewish history. Introduced students to Jewish civilization's key concepts, texts, and figures.

## Reading the Graphic Novel

Designed introductory freshman seminar for the Tulane Interdisciplinary Experience Seminar (TIDES) program. Intended to combine education with a strong communal environment, TIDES classes assist students in acclimating to the college environment while teaching them about topics not normally covered in university classes. Through reading of three acclaimed graphic novels, the seminar helped students to develop their reading and viewing skills for future college work.

#### Elementary Modern Hebrew I &II

Taught reading, writing, listening, and speaking of the Hebrew language four days a week. Designed lesson plans, wrote exercises and exams, graded student work, and held regular office hours.

## Intermediate Modern Hebrew I & II

Taught reading, writing, listening, and speaking of the Hebrew language four days a week. Designed lesson plans, wrote exercises and exams, graded student work, and held regular office hours.

#### **Visiting Research Scholar, Princeton University**

Sept – Dec 2005

Residential scholarship awarded post-hurricane Katrina. Researched Israeli literature & film.

## **Lecturer, Rutgers University**

From Sabra to Israelis

Jan – May 2005

Designed an introductory undergraduate Israeli literature class. This lecture class employed translated literary texts and film to explore the changing nature of Israeli identity from 1948 to the present.

Designed class. Developed reading skills through the reading of adapted and original texts, read in class and at home.
